The Event The event shall be a Multi-Club Khanacross (7th July) & Multi-Club Junior Motorkhana/Driver Development Day (8th July), promoted and organised by the Beverley Off Road Motor Sports Association (BORMSA). The event will be held under the International Sporting Code of the FIA and the National Competition Rules (NCR) of the Confederation of Australian Motor Sport Ltd (CAMS), the Khanacross Regulations, the National Motorkhana Code, these Supplementary Regulations and any Further Regulations authorised by CAMS.

This event will be conducted under and in accordance with the CAMS Risk Management and Occupational Health and Safety Policies. These policies and the CAMS Manual of Motor Sport can be found at <u>www.cams.com.au</u>.

Number of Entries	Limited to a maximum number of 40 entries for Khanacross and 20 (each) for the Junior Motorkhana and Driver Development Day.			
	A maximum of three entries per vehicle will be accepted.			
	If the number of entries submitted exceeds the maximum number of entries, first priority of acceptance will be given to BORMSA members in order of receipt of fully paid entries.			
	Entries may be refused in accordance with NCR 83 of the current CAMS Manual.			
Eligibility	Driver(s) must be a member of a CAMS affiliated Car Club in WA. Current Club Membership Cards and vehicle logbooks (if issued) must be produced at documentation.			
	Driver(s) must possess and produce a 2NSJ/2NS (or higher) CAMS Licence at documentation.			
	The Competitor shall provide written authorisation for the use of the vehicle in competition by the Driver(s) and acceptance of the Terms and Conditions by signing the disclaimer on the reverse of the entry form.			
	The minimum age for Khanacross drivers is 14. The minimum age for Junior Motorkhana is 12. Juniors (12 – 17 years) must have their entry form signed by their parent or their legal guardian.			
<u>Scrutiny</u>	The vehicle must pass scrutiny and comply with Group 4H and Schedule A (refer also Schedule J, where applicable) as per the CAMS Manual of Motor Sport. A fire extinguisher of at least 900g complying with Schedule H of the CAMS Manual of Motor Sport must be fitted. Vehicles must be adequately muffled to comply with noise restrictions.			
	Fuel must comply with Schedule G of the current CAMS Manual.			
	Scrutiny and documentation will be conducted at the BORMSA Motorplex, as per the Schedule below.			
	Cars shall be presented to scrutiny in a clean condition			
<u>Safety</u>	All drivers shall, whilst competing, wear at least a lap/sash type seat belt (unless exempted by registration with CAMS as a Historic Car).			
	Drivers and Instructors in Motorkhana specials and open top vehicles must wear a helmet complying with AS 1698 or Schedule D of the current CAMS Manual of Motorsport.			





Juniors must wear a suitable helmet. All competitors and instructors must wear a helmet complying with AS 1698 or Schedule D of the current CAMS Manual of Motor sport.

Goggles or a helmet with visor (AS1609-1981) must be worn in all open cars and in closed cars which have the windscreen removed.

- Apparel Neck to wrist to ankle, non-synthetic clothing must be worn; 100% cotton or wool garments (including socks) are acceptable. Suitable and appropriate footwear (e.g. with leather upper) must be worn; shoes made of synthetic material, thongs, roman sandals and high heels do not comply. Apparel must comply with Schedule D of the current CAMS Manual of Motor Sport (Autotest Table).
- TestsA minimum of 8 tests shall be conducted for the Khanacross. For the Motorkhana,
between 4 and 12 tests shall be conducted depending upon competitor numbers and
conditions. After competitors have completed the first set of tests, the courses will be
reversed and run again. This procedure will be repeated until the event concludes.
Fastest times on each test shall be collated to determine results. The
observer/timekeeper is deemed Judge of Fact.

<u>Awards</u>

This event comprises part of the 2012 BORMSA Club Championship outright and junior categories. For outright competitors, points will be scaled from 1st place to 15th place as per the following for 2WD cars: 20, 17, 15, 13, 11, 10, 9, 8, 7, 6, 5, 4, 3, 2, 1. Points for 4WD cars are as above but minus 8 points.ie.12, 9, 7, 5, 3, 2, 1. Junior Championship points shall be awarded as 5 points for 1st place down to 1 point for 5th place.

To be eligible for the Club Championship, competitors must be BORMSA members. To register a result for the Championship, a competitor must officiate/volunteer at a minimum of one event per year (excluding juniors).

Junior Motokhana:

This event comprises part of the 2012 BORMSA Junior Championship. Junior Championship points shall be awarded as 5 points for 1st place down to 1 point for 5th place.

To be eligible for the Junior Championship, competitors must be a junior BORMSA member and compete in a 2WD vehicle.

Driver Development Day:

No awards apply.

- **Protests**Protests must be lodged in accordance with Part XII of the current CAMS Manual.
The Clerk of Course will be the Judge of Fact.
- **<u>Postponement</u>** The organiser reserves the right to postpone, abandon or cancel the event in accordance with NCR 59.

The Junior Motorkhana and Driver Development Day may be cancelled if insufficient competitor numbers are received by close of entries. Alternatively, the Junior Motorkhana may be run simultaneously to the Khanacross event on Saturday 7th July 2012. All competitors shall be advised and a notice posted on <u>www.bormsa.asn.au</u> by Friday 6th July 2012.

Anti Doping Policy

During any event, consumption of alcoholic beverages in the paddock, pits or any other portion of the competition venue under the control of the officials is expressly forbidden until all practice or competition activity is concluded for each day. Any driver or crew member who is found to be affected by alcohol on the day of the event or practice therefore shall not be permitted to participate. Refer NCR 145A of the Current CAMS Manual. In addition, the persons concerned will be subject to the Articles of the Standard Operating Procedure for Alcohol Testing and CAMS Anti-Doping Policy. Competitors, crews or officials may be randomly tested for alcohol by





a CAMS Accredited Testing Official (CATO) or other drugs at any time during the event(s).

The CAMS Anti-Doping Policy, as appears in the CAMS Manual of Motor Sport and as amended from time to time, is recognised as an integral component of the NCR and is duly authorised as such. In any areas where the National Competition Rules and the Anti-Doping Policy conflict, the Anti-Doping Policy will take precedence.

<u>Insurance</u> Insurance for this event will be provided in accordance with Appendix I of the current CAMS Manual.
